PETITION / MOTION TO MODIFY CHILD SUPPORT

I. Introduction

II. Jurisdiction and Venue

VII. Current Financial Information

VIII. Proposed New Support Amount

18. Applying the current figures to the [STATE] guideline, Petitioner requests that the Court order **Petitioner** to pay child support in the amount of **** per month, effective .

19. This represents a **no change in dollar amount but a change in payor or allocation** of per month from the Existing Order.

20. **Retroactivity.** Pursuant to 42 U.S.C. §666(a)(9), any modification ordered shall take effect no earlier than the date of service of this Petition on the Respondent. Petitioner does not seek, and the Court may not grant, modification retroactive to any date prior to service.

IX. Income Withholding

21. Pursuant to 42 U.S.C. §666(a)(8) and (b), Petitioner requests that the modified support amount be collected through immediate income withholding by wage-assignment order served on the obligor's employer.

X. Prayer for Relief

WHEREFORE, Petitioner respectfully prays that this Court:

- A. Find that a substantial and material change in circumstances has occurred warranting modification of the Existing Order;
- B. Modify the Existing Order to require **Petitioner** to pay child support of **** per month, effective ;
- C. Order that collection be made through the [STATE] State Disbursement Unit by income withholding;
- D. Order such arrears relief, if any, as is just;
- E. Award Petitioner reasonable attorneys' fees and costs where permitted by [STATE] law; and
- F. Grant such further relief as the Court deems just and proper.
