RESOLVED, that the Bank is authorized to honor, receive, certify, or pay all instruments signed in accordance with the signature requirements below, even if drawn to the individual order of, or payable to, or deposited to the personal credit of, any authorized signer;

RESOLVED, that the following persons are designated as **Authorized Signers** with respect to the Company's accounts at the Bank:

RESOLVED, that the signature requirement for instruments drawn on Company accounts shall be: **any one (1) Authorized Signer acting alone**;

RESOLVED, that the Authorized Signers, acting in accordance with the signature requirement above, are authorized on behalf of the Company to: (a) sign, endorse, and deposit checks, drafts, notes, and other instruments; (b) withdraw funds from the Company's accounts by check, draft, wire transfer, ACH, or electronic means; (c) sign, countersign, or endorse in blank any check, note, draft, bill of exchange, or other instrument on which the Company is named as drawer, payee, or endorsee; (d) execute agreements relating to treasury, cash-management, online banking, merchant-card processing, lockbox, remote-deposit-capture, and similar services; (e) obtain debit cards, credit cards, and safe-deposit-box access for the Company; and (f) designate users and access levels on the Bank's online-banking and treasury platforms;

RESOLVED, that the Bank is authorized to rely upon this Certificate until it receives written notice of change or revocation, signed by a duly authorized officer of the Company;

RESOLVED, that the officers of the Company are, and each of them hereby is, authorized, empowered, and directed, in the name and on behalf of the Company, to take any and all such further actions, and to execute, deliver, and file such further agreements, certificates, instruments, and documents as such officer(s) may deem necessary or appropriate to carry out the purposes and intent of the foregoing resolutions, the taking of any such action or the execution of any such document being conclusive evidence of the authorization hereby granted; and it is further
